Our publication is produced on a Macintosh platform. Files created on a Macintosh platform are preferred. Files created using a PC can only be accepted if properly saved as a Press Quality PDF. Publisher reserves the right to charge for all costs incurred in preparation of material submitted that does not meet the following specifications:

- Preferred File Format: PDF-X 1/a. If this is not possible, we will attempt to make the PDF for you. Additional costs may be incurred.
- All spot colors should be converted to CMYK.
- Do NOT send files in RGB.
- All fonts must be converted to outlines.
- All images in your ad must be hi-resolution (300dpi)
   CMYK files. Images should not be scaled more than 115% to maintain image quality.
- Layered files must be flattened.
- No crop marks.
- Whenever possible, please avoid type effects such as shadowing, distorting, etc. Your layout program may not successfully convert these effects to PDF.
- All 2-Page Spread ads should either be prepared as a single ad crossing gutter (do NOT set text and critical graphics across gutter) –or– two full page ads. (see dimensions)



- If a brand font is required and is not in Adobe Fonts we will come as close as possible.

We may scan your logo or photos if no digital files exist.
